

## INDEPENDENT 2012 2013 Verification Worksheet Federal Student Aid Programs

Your application was selected for a process called verification. The law states we have the right and responsibility to ask you for this information before awarding Federal aid. If there are differences between your FAFSA information and your financial documents, corrections will be submitted electronically to have your information reprocessed.

- 2. Attach any required documents and submit the completed worksheet to your financial aid office as soon as possible, so that your financial aid won't be delayed.
