

## Office of Financial Aid 2013/2014 Unusual Enrollment History (UEH) Appeal

Your 2013-14 Free Application for Federal Student Aid (FAFSA) has been flagged for "Unusual Enrollment History Review" by the U. S. You must complete this appeal form, attach the requested documents, and return to the Financial Aid Office. If you have questions, contact us promptly so your financial aid will not be delayed. If your appeal lacks the requested documents or you leave information blank, the process will be significantly delayed.
