

New hardwood flooring throughout McDaniel Hall adds to its timeless charm. Holmes is proud to see one of our most historic and iconic buildings restored for generations to come.



McDaniel Hall Renovations

Constructed in 1915, McDaniel Hall is the oldest building on our Goodman Campus. With over 20 years of wear and tear, the last renovation took place in 1992.

Thanks to a generous donation from John and Mary Brock, Holmes Community College was able to do extensive renovations to McDaniel Auditorium during the 2019 summer and early fall. Inside the auditorium, the college refurbished the wood flooring, added new seats along the outsides, painted all the walls and ceilings, and added new carpet runners between the restored seats and drapery panels that can be opened and closed during productions. A video booth was also built in the back of the auditorium that matched the remaining walls in the auditorium and added two large TVs to enhance the viewing experience. The foyer received

new flooring and paint and the restrooms were totally renovated. The college also added refurbished knotty pine wood flooring with natural finish and paint throughout McDaniel Hall to mirror what was done in the auditorium and foyer.

John Brock is the grandson of Holmes' second president, Major Cyrus McDaniel, who served Holmes as president from 1928-40.

About The Foundation

Holmes Community College Development Foundation was established more than 40 years ago to represent the nine county district the college serves. Its purpose is to provide funds for scholarships for students attending Holmes and other educational activities of the college, such as faculty development, modernization of classroom equipment, student development activities, and sponsorship of capital improvement campaigns.

Holmes House

Holmes House is a nonprofit entity established by the Holmes Community College Alumni Association. The facility is available for alumni, staff and friends of the college to use. All profits are used for the refurbishment and upkeep of Holmes House. Lodging includes use of the self-catering set up for the kitchen, spacious sitting areas, and a private room with a bathroom.

Lighting the Way

The Foundation conducted the Lighting the Way Campaign in which \$1.5 million was raised to support college programs. The Foundation also raised funds amounting to \$750,000 for the building of the Chapel on the Hill which serves as the centerpiece for the campus and is used for recitals, weddings and other religious activities.

Capital Campaign

In 2016, the Foundation completed a Capital Campaign exceeding \$15 million. The mission of this campaign was to obtain support for student scholarships, instructional technology, program start up, etc.

olmes Community College is proud to announce that the Holmes Community College **Development Foundation**, Inc. has been named as one of the 2020 grant recipients selected by National Endowment for the Humanities (NEH) Infrastructure and Capacity Building Challenge Grant on behalf of the McMorrough Library and Archives. The HCC Development Foundation sought the NEH matching grant to strengthen and aid the library in warranting excellent humanities provisions.

The NEH grant will provide the Foundation with \$231,849, and the Foundation will be responsible for matching these funds through donations. The McMorrough Library and Archives Renovation Project is dedicated to the preservation of humanities and seeks to provide an inclusive environment, offering informative programs to cultivate critical-thinking citizens.

"We are very pleased to be awarded these funds." said Holmes President, Dr. Jim Haffey. "This is a premier grant that will allow us to modernize the lifeblood of our main campus, the library. A library should be the epitome of a welcoming place to expand one's knowledge such as the humanities. We have not had a significant renovation of the library in decades so we are elated that we can work hard and raise the matching funds to do a renovation that we can be proud of for generations to come."

As part of the proposed efforts to enrich and diversify the scope of humanities, the Development Foundation, which is a 501(c)(3) organization, has a five-year plan to renovate the 1975 structure's interior spaces and their contents. The new multidimensional spaces projected by the McMorrough Library and Archives Renovation Project will secure the practicality of activities set forth by the humanities departments as well as advance the library to become an innovative leader among Mississippi's 15 community college libraries.

Individuals who utilize the McMorrough Library and Archives will benefit from this renovation. making the impact of this project vital to secure the long-term perpetuation of the humanities for not only the college but also its neighboring communities. The Foundation will host a kick off to launch a matching campaign for the grant in the near future. Food, Fellowship and Holmes

Unselfishly feeding Bulldog athletes, Steve Sizemore has won more than cooking competitions, he's won our hearts too.

Steve Sizemore has been exceedingly generous with his time and contributions to the sports programs at Holmes over the years. As owner of the Longhorn's Steakhouse in Newport, he has graciously provided numerous catered meals for the athletes.

The Longhorn's Steakhouse is famous for the steaks, which Sizemore cooks himself along with his locally celebrated steak sauce. When the restaurant opens on Thursday, Friday and Saturday nights, it can be difficult to find a parking place. A person can order just about anything, from fried mushrooms to hamburgers to ribeyes, and will not go away hungry.

Sizemore has been cooking for many years and learned his way around the kitchen from his mother. Originally from Cleveland, he started out grilling around the house with some friends, which snowballed into entering bar-b-que competitions. "At the time, we had never done anything close to competing for our cooking, but we ended up winning the competition." Sizemore said.

After graduating from Cleveland High School, Sizemore went to Mississippi Delta Community College and continued his studies at Delta State University, where he earned a Bachelor of Arts degree in Business Administration.

In 1994, Sizemore married his wife, Stacie, who is from Newport. Stacie is a Holmes alumna who continued on to earn a B.S. from the School of Pharmacy at the University of Mississippi. The Sizemores have three daughters: Alex (23), Cassidy (20) and Rylee (15).

In 1995, they opened a steakhouse restaurant in Kosciusko, later relocating to where the restaurant stands today. The large drawing area for the restaurant has contributed to the Longhorn's



Steakhouse's success, in addition to catering corporate events like the National Wild Turkey Federation Banquet.

"People do not mind a little drive, and our customers just keep coming back," Sizemore said.

In 2008, the restaurant was closed following a devastating fire, but Sizemore steadily continued to cater events for his patrons. In 2013, Sizemore rebuilt and reopened the restaurant, and the tables were full again with loyal customers.

When Sizemore's oldest daughter enrolled at Holmes, he became more involved with the college. As his love of the college continued to grow, he started cooking more often on campus, especially for the athletic teams.

Sizemore has shown his love for Holmes by opening up his restaurant on Tuesday nights in the fall to host the "Jeff Koonz Radio Show." Prior to beginning the radio show, Sizemore was also instrumental in the Alumni Association's Wild Game Dinners held in the late 1990s.

Sizemore will be recognized at the Sports Hall of Fame Banquet on April 2, at Holmes Community College in Goodman for the Special Service Award. The Special Service Award is an honor Holmes occasionally bestows on an alumnus or non-alumnus who goes above and beyond in service to the college.

Yates Honored with Shelton Award

Holmes employees are nominated by their peers for the Paul & McCrea Shelton Award. This year, Mike Yates won based on his support of the college, dedication to students and community service involvement.

ike Yates is music coordinator and director of the Holmes Connection! and Coachmen Singers. He is also the Associate Chair for the Fine Arts Division. as well as the advisor and teacher for Entertainment Industry Studies. Referencing his personal experiences on campus, Yates stated, "Holmes Community College has always been a special place for me. I thoroughly enjoyed my time spent here as a student and it was my goal to be able to come back and teach here. I consider it an honor and privilege to be a part of the Holmes family and am thankful that I have been able to spend the last 13 years here as an employee."

Yates is a native of Kosciusko where he graduated from Kosciusko High School. He is an alumnus of Holmes and a recipient of the Elmo and Mary Glenn Scholarship, Presidential Scholarship and Graduate Assistant Scholarship. He attended the University of Southern Mississippi where he graduated with honors and received his Bachelor of Music Education and Master of Music Performance.

At the Holmes Goodman Campus, Yates coordinates daily and nightly rehearsals and directs performances for both the Coachmen Singers, which consists of six singers and musicians, and the Holmes Connection!. which consists of 14 singer-dancers and five crew members. Under Yates' direction, these two groups prepare for the annual Homecoming Show, Carols of Christmas and Pops Concert, as well as other community performance events. Billed as a "must see," these performers are all considered ambassadors of Holmes and perform for the Major Experience, an annual recruiting event that has hosted 350-400 students on campus each year.



Realizing many of his students had a desire to learn about careers they might pursue in the entertainment industry, Yates made it his mission to create and design a program especially for Holmes. Using Yates' design, and with the assistance of Dr. Jenny Bailey Jones and Dr. Tonya Lawrence, his vision of expanding students' horizons in the entertainment industry was finally realized in 2016 when the Entertainment Industry Studies Program was established as the first course of its kind for Holmes.

When not on campus or at a Holmes performance, Yates can be seen playing bass and directing one of Style Entertainment's featured bands, Stylish. They perform in wedding venues throughout Mississippi and neighboring states and have recently been voted "Best of Weddings 2020" by *Mississippi Magazine, The Knot* and *Commercial Dispatch* in the Golden Triangle.



FACULTY SPOTLIGHT

Started on the Ground, But the Sky Was the Limit

Mark Galtelli was raised in Clarksdale but found his calling in Emergency Medical Sciences right here at Holmes Community College.

Galtelli's resume is impressive with degrees from The University of Mississippi Medical Center (UMMC), The University of Mississippi and Louisiana State University-Shreveport. It is apparent Galtelli is passionate about his field of study, as he is a published expert on EMS and has researched

areas of medical rotor-wing aircraft and intubation.

It all began when Galtelli was going to school at Holmes during the day and working at night as a paramedic with American Medical Response in the Jackson area. When Galtelli started in the EMS industry, there were no ambulance stations, as the ambulance itself was the station for the entire shift.

"Looking back, I would not trade it for anything," Galtelli said. "I can remember working as a paramedic seeing the ECO units from Jackson Fire Department breezing in and out. They looked so cool. Little did I know that was the next step in my career, and now almost 30 years later, I am still here."

Galtelli has just under 10 years with AirCare, a medical flight program associated with The University of Mississippi Medical Center. During this time, he has served as a flight paramedic, worked as the community outreach coordinator and was a former senior flight paramedic.

Currently, Galtelli holds two positions: one with Med-Trans Corporations out of Texas as their program manager and the other with Holmes Community College as our EMS program director. Galtelli accepted the position at Holmes in 2008, and since that time, the EMS program has expanded to two of the campuses, Ridgeland and Grenada.

"Holmes has a large impact with the industry as we wrote and helped design the [Mississippi] Critical Care Paramedic curriculum along with crafting a new design for EMT and paramedic," Galtelli said. "We are the cutting edge of EMS and have a positive influence throughout the state."

The EMS program is offered August through July. and Holmes is the only community college to have two paramedic programs. Holmes prepares students for a variety of roles in the field of emergency medicine by way of dedicated faculty. The program offers its graduates several opportunities of work schedules with a wide range in base salary.

Students who complete the one-semester EMT course at Ridgeland or Grenada and receive licensure are prepared for direct patient care and serve as the support personnel as well as ambulance operators. They also have qualifications to work in emergency departments, fire departments and physician offices. Current licensure as an EMT often provides points toward entry selection into other allied health programs.

"We don't ever let our students go," Galtelli said of Holmes. "Some students might be taking a refresher and others just continuing their professional growth, but they just keep coming back. It is home."

Galtelli established a scholarship with the Holmes Community College Development Foundation, which will be endowed this year, called the Holmes EMS Scholarship. Scholarship recipients must have a minimum ACT score of 18 and be enrolled during the second semester of the EMS Paramedic Program on the Ridgeland or Grenada Campus.

Galtelli and his wife. Susan, reside in Canton. They have two daughters, Grace (23) and Sara Donnelly (26), along with their first grandchild, Della Rae.



Depending on who you ask, Becky or Jesse, the story may be a little different, but either way, it is a sweet one.

1967 Holmes CC Coachman Director Foster Hollingsworth had a Coachmen record created, which Jesse saved and his children framed. he Leverettes are a prime example of people who love what they do, and it shows. 


